Terms & Conditions of Use

1. A valid Annual Pass admits the named person to Weston Park during our normal opening hours on valid dates for 12 months from the date of issue not the date of first visit (please see weston-park.com for full opening dates and prices)
2. An Annual Pass is to be used by the named holder and is non-transferable
3. If any Annual Pass is found to be used by another party and not the named user Weston Park reserves the right to withdraw the pass from use without a refund
4. When visiting Weston Park please ensure that you have your Annual Pass card with you. Only the person pictured on the card will be admitted in to Weston Park
5. Member information required includes: name, address, telephone number, e-mail (where available) and date of birth (optional)
6. Each named Annual Pass card holder (excluding children) will have a digital photograph taken upon purchase. This is required to validate membership. This image, along with address details will be held by Weston Park Enterprises Limited in accordance with the General Data Protection Act (GDPR) May 2018. Weston Park does not sell or share data with third parties
7. Every time you visit Weston Park you will need to have your Annual Pass card scanned at the Admissions Desk
8. Any lost, stolen or defaced cards will be replaced at £10.00 per card
9. Weston Park Annual Pass Holders can enjoy 10% off purchases in the Granary Brasserie upon presenting a valid Annual Pass. This is valid for up to eight diners in the Granary Brasserie. Cannot be used in conjunction with any other offer or promotion. Excludes Sunday Lunch and special events including Valentines, Mother's Day, Father's Day, Christmas Day, Boxing Day, New Year's Eve and New Year's Day
10. Membership card must be presented in the Granary Brasserie to be scanned to obtain 10% discount
11. Weston Park Annual Pass Holders can receive 10% off purchases in our pop-up Gift Shop upon presenting a valid Annual Pass. Sales must exceed £1.00 and cannot be used in conjunction with any other offer or promotion or on Guidebooks
